## 8. LEADERSHIP REPORT:

Chief Novak:

The District ran 25 calls in July: 2 ALS, 6 BLS, 2 Cancelled Calls, 1 Structure Fire, 9 Motor Vehicle Collisions, 2 Wildland Fires, 2 Investigations, 1 Public Assist and 1 Motor Vehicle Collision with Fire.

The District received 2 checks from Arizona Forestry.

Staff have fulfilled about half of Becky Phifer's Public Records Request.

The old brush truck has been paid for and shipped. The District will receive a check from Public Surplus for \$20,600.00, in August, for the sale of the truck.

The type 3 Engine is back and ready for another call out.

The lettering has been placed on Brush 2502.

The Fire District handed out bottled water to 24 families and filled numerous non-potable containers during the water outage.

The Fire District shuttled 6000 gallons of water to the school to fill the new septic tanks, as they had to be full of water upon inspection.

## Captain Lentz:

Training: Continuing new recruit training, training via Action Training and IMD.

School: District will continue to provide on site medical for games and events. Both Junior High and High School Volleyball Season is starting soon.

District Calls: Call volume has remained steady, with a variance in the types of calls received.

Equipment Inventory: Ongoing procedures for medical and supply inventory. Appreciates the Boards support of the volunteers and the Communities support of the Fire District.
